Motion to change the order of business made by Nancy and seconded by Josh, to introduce Anthony Priester. Norm presented Anthony as a prospective Senior Choir Director. He is a Junior at Peru State, majoring in Music Education. His goal is to teach High School Music. Job Description and Compensation were discussed and he had no questions. Norm reported that Terry Weible is making Nursing Home visits and providing Communion to them. Michael Schmidt from First Christian has offered his services to us for emergencies, funerals and such.

Nancy, serving as Church Secretary, reported that A1 Locksmith was unsuccessful in replacing the current key fob system so a new system will need to be purchased. Mike said he would work to get estimates, to include security updates such as cameras and recording ability. Have statements from Premier Bank on the Youth Fellowship fund. Jen Tietz's name is on the unactive groups account. We will work with the Board of Chistian Education to determine who will take charge to the account. Sandy presented the 2022 Liability Policy, clarifying the questions voiced last meeting regarding overage for lost or stolen funds. The 2023 policy will be sent to us soon. Nancy will keep a copy in the office. An application has been received for the Secretary position. Resume was reviewed. Interview will be set up for Friday 9/22 at 10am. Board members Brian, Norm and Nancy will be able to conduct the interview. Larry will check references.

Margaret, Memorial Officer reported no Memorials have been received this month. The account remains at \$88,176.89. No changes in the CDs since annual report. Received additional money to be used to honor Pastor Keiths years of service. Buying a hand microphone for the Sound system was suggested, Mike will check on the cost.

Mike reported that Spiritual Council recommends the Board consider Rev Jacob Colligan to serve as our Interim. The Board will take this under advisement.



Michelle reported that The Board of Christian Education members are Brianna Johnson, Erin Johnson, Carrie Ferguson and Danielle Barrett. They have been planning a new format for Sunday School and Confirmation. They are hoping to be ready to start October 1. They are planning a Musical for a Christmas Program.

Buildings and Grounds Chairmen Michael Wieckhorst. The Roof repair will be on hold until the Steeple damage is

assessed by the Insurance Co. It is estimated to add an additional \$115,000 to the cost. Miracle Mud jacking was consulted regarding repair of leaking wall area. Mike and Dale will repair this winter. There are 5 valances that need to be replaced. Mike asked if we want him to replace them or have an Electrician do it. If there would be a fire due to them, the insurance will cover the damage when work is done by an Electrician, not by us. Nancy moved to have an Electrician replace the valances, died due to a lack of a second. Mike will investigate this further. Mike is talking to two companies for estimates on a new door locking system for 2 doors, along with recording cameras.

Michelle reported for the E and F Team. The Turkey Trot event will be shared with the Wellness Center this year. The 5K run will be November 18. Proceeds will be split 50-50. We are to obtain sponsors and design t-shirts; the Wellness Center will do the advertising and provide the labor. The Trunk and Treat is being planned for Sunday afternoon October 29th from 3-5. Will be serving Hot Dogs, Chips and Pop as last year, all items are donated. The Living Nativity is planned for Saturday, December 16th and 23rd. The Creative District in Nebraska City has asked if we would be agreeable to present it on the 22nd. This is in conjunction with the Tour of Lights.
