Under member comment time, Richard commented that we have not been forthcoming to others about why Pastor Keith left. Members voicing "They don't know". He left because he felt disrespected by the Church membership.

Reading of Minutes by Nancy, motion to approve was made by Josh and seconded by Jason, passed.

Financial Report was made available for review by members. Sandy reported she will not be able to attend services the rest of the year but will continue to service as Financial Officer. A1 will be here Wednesday to place the locking system on the computer so key bobs can be processed and remote lock continue. He will need to reprogram all the key bobs, so let us know if yours is not working. Our organist will be out October 15.

Margaret, Memorial Officer, reported that \$725 has been received this month, making the total of \$88,176.89 in the account. No changes in the CDs since annual report. 


